**CLINIC**

In 2010, OK Humane performed 12,567 spay/neuter surgeries, a huge increase from the 2009 number of 7,232 surgeries. In 2011, OK Humane is on track to perform over 15,000 spay/neuter surgeries. OK Humane has focused energy and resources to marketing services to the four zip codes that produce the largest number of intake animals into the Oklahoma City Animal Shelter. In 2010, OK Humane hired 2 part-time employees called spay/neuter liaisons. These employees work directly in the targeted zip code neighborhoods going door to door promoting spay/neuter. The Oklahoma City Animal Shelter saw an 800 animal decrease in intake in targeted zip codes after one year of placing the spay/neuter liaisons in the neighborhoods. To compliment their marketing efforts a number of incentive specials were introduced. For example, the clinic is now offering the "Fix Your Pit" program which allows any citizen from one of the four targeted zip codes to pay whatever they can pay to spay/neuter their Pit Bull. Also, in those same four zip codes the clinic is offering a "Spay Your Momma" special which enables anyone that brings in their breeding female dog or cat for surgery to also get their puppies or kittens altered for free. The OK Humane Place Spay/ Neuter Clinic also has a transport program that enables the spay/neuter liaisons to transport the animals from the targeted areas to the clinic, removing yet another barrier to owners spaying/neutering their pets.

**ADOPTION**

Ok Humane performed 2,601 adoptions in 2010 which was a substantial increase from previous year's 2,136 adoptions. The staff continued to press on by implementing widespread adoption specials and events throughout the year. OK Humane experienced great success in planning and hosting 2 mega-adoption events called Midnight

Woofness. The first event performed 388 adoptions in 41 hours and the second event performed 485 events in 41 hours. Both of the Midnight Woofness events set national adoption event records. Another focus in 2010 was the planning and fund-raising for a new Quarantine Facility for the Homeward Bound long-distance transport program. In this program large numbers of dogs and puppies will be transported out-of-state after completing a quarantine period in the new quarantine facility next door to the Oklahoma City Animal Shelter. Each of these varied methods of adoption will continue to directly increase the live release rate.
