Street Text: Art from the Coasts & The Populist Phenomenon

October 2 – December 11, 2010

Street Text was a two-part exhibition examining Street Art and its evolution into a worldwide cultural movement. The upstairs portion of the exhibition titled *Art From the Coasts* was curated by Andrew Connors, Curator of Art at The Albuquerque Museum. He compared masters of graffiti art from New York and Los Angeles, including the work of Chaz Bojórquez, Gajin Fujita, John Lorne and Lady Pink, as well as the documentary photography of Henry Chalfant. The downstairs portion of the exhibition titled *The Populist Phenomenon* was curated by Francesca Searer of 516 ARTS. It included a mix of local, national and international artists, and examined the artists' work as a means of expressing a message to the masses. Work included on and off-site installations, photographic documentation, portable representations of wheat-paste, stencil and canvas work methods and video clips and films of street artists in action. This exhibition was the center of a citywide series of events titled ***STREET ARTS: A Celebration of Hip Hop Culture & Free Expression*** during fall 2010, presented in partnership with the ACLU-NM and involving 25 local organizations. The project celebrated art in the urban environment and explores issues of free expression.

Artificial Selection

April 24 – June 26, 2010

Artificial Selection was a group exhibition which brought together art, science, myth and technology. It examined contemporary artists' responses to the processes of adaptation, mutation and survival when the natural order distinguishing species or machine becomes less distinct. Hybrids pervade our mythologies and religions and continue to play an influential role in the way we perceive our capabilities as a creative species. The selective breeding and cross-breeding of plants and animals for domestication was only the beginning of what science is enabling us to create in the 21st century. The exhibition raised questions about the consequences of the process of artificial selection. It featured local and national artists and was curated by Rhianon Mercer, 516 ARTS.

Form & Function

February 6 - April 3, 2010

Form & Function was a group exhibition featuring the work of artists and designers who explore sustainability, reuse, decoration and innovation. From alternative rugs, lighting, furniture and jewelry, to eclectic art objects that riff on function, viewers found treasures for live and work spaces by renowned artists from New Mexico, across the country and beyond.

Unraveling Tradition / Restoration

July 17 – September 11, 2010

Held in the downstairs gallery, *Unraveling Tradition* focused primarily on sculpture and installations, featuring the work of artists who use fabric, yarn, thread and various fiber media to create nontraditional objects and assemblages. They conveyed contemporary ideas and concerns, using traditional handwork techniques such as weaving, sewing, embroidery, felting, knitting and crochet. Held in the upstairs gallery, *Restoration* featured contemporary work by artists who have worked in the antique textile restoration and conservation fields. In their own artwork, these artists reference traditional textile materials and techniques, the practices and metaphors of restoration/conservation and the beauty and inspiration of the artifacts with which they work. Both exhibitions were held in conjunction with *Convergence: Albuquerque 2010*, the International Fiber Arts Conference.

El Otro Lado: The Other Side – Albuquerque

Educational Outreach Program

El Otro Lado: The Other Side was a community-based arts project that engaged an interdisciplinary, creative process to explore our human connection to land, our sense of home and belonging, and our sense of boundaries and cultural divides. Artist Chrissie Orr and writer Michelle Otero led intergenerational, cross-cultural workshops, in which participants told their stories through the use of journaling, recorded oral narratives, photography, visual arts and written expression. The public was invited to participate in the free workshops at West Side Community Center and Barelás Senior Center, and Chrissie Orr and Michelle Otero led workshops with the Native American Community Academy and at Plaza de Encuentro Gathering Space (a consortium of groups consisting of El Centro de Igualdad y Derechos, Enlace Comunitario and Southwest Creations Collaborative). The culminating public storytelling event took place at the National Hispanic Cultural Center in November, 2010.
