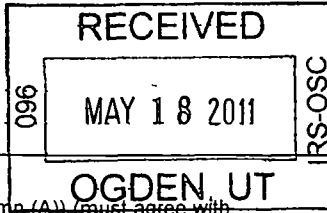





THE CHILDREN'S LEAGUES PRACTICE IN BROWNSBURG, INDIANA AND ALL ACTIVITIES ARE PREDOMINANTLY FUNDED BY MODEST REGISTRATION FEES AND BUSINESS SPONSORSHIPS. MORE THAN 85% OF THE ORGANIZATION'S OPERATIONS AND ADMINISTRATION IS RUN BY UNPAID VOLUNTEERS.
