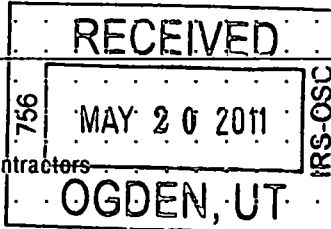



HARVARD CLASS OF 1961

PART III - Activities and Operational Information:

1. The Harvard Class of 1961 (hereafter "the Class") receives its financial support from contributions received primarily from alumni classmates and charges from specific occasions, such as reunions, class dinners and football parties.

2. The Class does not engage in a fund raising program.

3. The Class is the official class organization of the Harvard College Class of 1961. It was formed in 1961 for the sole purpose of furthering the interests of Harvard College (hereafter, "Harvard") by promoting and encouraging the members of the Class to retain their involvement with Harvard.

The Class has carried on activities for the exclusive benefit of Harvard. These events and activities include the following:

- a. Quinquennial class reunions, involving classmates and Harvard faculty and administrative staff participating in seminars, symposia and social events;
- b. Meetings in the Boston area and occasionally in other major cities, with speeches from classmates and/or Harvard faculty;
- c. An annual gathering before and/or after a Harvard football game;
- d. Annual Class Headquarters in Harvard Yard on Commencement Day;
- e. Class reports or directories published quinquennially at the time of the Reunions, updating the records of the Class and sent to all members;
- f. Annual or more frequent letters to all members of the Class from the Class Secretary;

g. Periodic class information published in the class notes section of the bi-monthly Harvard Magazine which is sent to all alumni.

The Class's involvement with Harvard is substantial. Harvard is dependent on the interest and dedication of its alumni for its continued successful functioning. The senior governing body of Harvard, the Board of Overseers, is elected by alumni and has traditionally been composed almost exclusively of alumni. In addition to reunions, football parties and other annual gatherings, a "Return to Harvard Day" is held every five years at which time members of the Class have the opportunity to audit classes and generally catch up on what has been going on at Harvard since their college days. A copy of the program for 1984's return to Harvard is attached to this application as Exhibit A.

Harvard provides the Class with such support services as typing, printing, mailing, the maintenance of class records and assistance in the planning of reunions and other class activities. Most reunion and class activities take place at Harvard locations. Most Class gatherings feature a speaker who is affiliated with Harvard.

Membership in the Class is open to all those who have been classified as the Class of 1961 by the Harvard
