Secretary or the Treasurer, may enter into any contract or execute and deliver any contract or other instrument, the
execution of which is not otherwise specifically provided for, in the name and on behalf of the Project. The Board of
Directors, except as otherwise provided in these by-laws, may authorize any other or additional officer or officers,
agent or agents, of the Project to enter into any contract or execute and deliver any contract or other instrument in
the name and on behalf of the Project, and such authority may be general or confined to specific instances. Unless
authorized to do so by these by-laws or by the Directors, no officer, agent or employee shall have any power or
authority to bind the Project by any contract or engagement, or to pledge its credit, or to render it liable pecuniarily
for any purpose or in any amount.
