MECEP hosted a conference in 2010 called MAINE'S ECONOMIC RECOVERY - STATE & FEDERAL ROLES. We also hosted a weekly television talk show called State of the State, focusing on a wide range of issues, including Prescription Drug Reform, Buying Local, Women and the Maine Economy, Maine's Energy Future, Financing Transportation, and much more.
