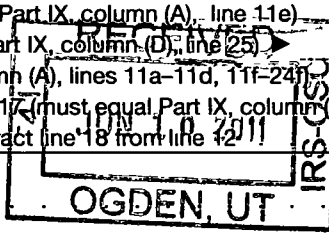

DECEMBER 31, 2010 AND 2009**

**NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

The Kevin Carter Foundation is a non-profit organization incorporated in Nashville, Tennessee. The Organization was formed to sponsor charitable and educational programs and events primarily for youth development. The Organization's primary source of revenue is its fundraising event, the *Waiting for Wishes Dinner and Auction*. The primary recipient of the organization's generosity is Make A Wish Foundation.

Basis of accounting - The financial statements have been prepared on the accrual basis of accounting. This method of accounting recognizes revenue when earned and expenses when incurred.

Cash and cash equivalents - For the purpose of reporting cash flows, cash and cash equivalents include cash on hand and cash deposited in banks.

Estimates - The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Donated services - Services are donated by many individuals who are members of the Organization. These services are not recorded in the accounts of the Kevin Carter Foundation as the Organization does not exercise control over employment of the donors nor does it have a clear, measurable basis for the amount of services.

Federal income taxes - The Organization qualifies as a not-for-profit organization exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code. Accordingly, income taxes are not provided.

**NOTE 2 - RESTRICTED FUNDS:**

Funds received from donors indicating a specific use for the money are accounted for separately. There were no restricted funds at December 31, 2010 and 2009.

**NOTE 3 - NONCASH INVESTING AND FINANCING ACTIVITIES:**

There were no significant noncash investing and financing activities for the years ended December 31, 2010 and 2009.
