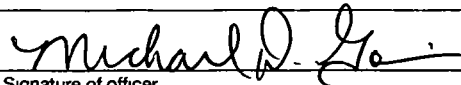

The Marietta Police Athletic League (MPAL) co-hosted the second annual Youth & Law Enforcement Symposium with the purpose of
bridging relationships between area youth and law enforcement. In 2010, the organization continued its involvement in / sponsorship of the
6th Grade Basketball Program, summer swim lessons, tutoring program, Marietta YELLS Mentoring Program, martial arts lessons, Early
Learning Initiative, and the Family Stability Project. Dance lessons were added to this year's programs. Community outreach and
recreational activities for 2010 were golf, bowling, Back to School Bash (providing free backpacks and school supplies to area youth),
and Holidays Around the World (providing holiday gifts to area youth).
