The United States Medical Licensing Examination (USMLE) is a three-step examination for medical licensure in the United States and is sponsored by the Federation of State Medical Boards (FSMB) and the NBME The USMLE program supports medical licensing authorities in the United States through its leadership in the development, delivery, and continual improvement of high-quality assessments across the continuum of physicians' preparation for practice It assesses a physician's ability to apply knowledge, concepts, and principles, and to demonstrate fundamental patient-centered skills, that are important in health and disease and that constitute the basis of safe and effective patient care Note The expenses reflected above do not include institutional indirect expenses

The Health Profession Services program provides comprehensive assessment, educational, consultative, and research services for healthcare organizations During 2010, NBME's Health Profession Services worked with 25 organizations to administer over 60,000 examinations for purposes of licensure, certification, maintenance of certification, evaluation of special competence, in-training, and self-assessment These organizations included allied health professional associations, the national veterinary licensing board, members of the American Board of Medical Specialties, and medical societies Examinations are administered worldwide Note The expenses reflected above do not include institutional indirect expenses

That is, applications addressing the same substantive study topic by the same investigators may be submitted for Fund consideration no more than a total of three times. - The primary investigators of prior Fund grants are eligible to reapply and compete (with new applicants) for one additional award through the Stemmler Fund Call for Letters of Intent for the same line of study. Current award recipients are eligible to compete again only if any current NBME support is expected to terminate satisfactorily by the beginning of the 2010-2011 project period (usually July 1, 2011). Selection Process 1. All submitted Letters of Intent will be reviewed by NBME staff to ensure eligibility and completeness. 2. The Stemmler Fund Steering Committee will then evaluate Letters of Intent on the extent to which the proposed research is innovative or will advance assessment in medical education or practice, and addresses an important problem or issue in medical education or practice. 3. The Stemmler Fund Steering Committee will then meet to select a subset of Letters of Intent (e.g., 10-15) and invite the principal investigators to submit full proposals. 4. All Invited Proposals will be reviewed by NBME staff to ensure completeness. 5. Peer reviewers with expertise in measurement, research design and methodology will then evaluate Invited Proposals on the relevance and significance of the proposal to the purpose and goals of the Stemmler Fund, the adequacy of the research design or methodology, and the qualifications of the principal investigator and project staff. 6. The Stemmler Fund Steering Committee will then review all proposals and peer reviews, giving careful consideration to the adequacy of the budget, timetable, and other key project resources in each proposal, and select awards. The NBME will provide feedback detailing the comments provided by reviewers of applications not selected for funding. Grant Fund Use Monitoring Grant recipients are required to submit an interim and final report which includes a Final Project Narrative and a Final Project Fiscal Report.

Form 990, Part III, Line 4d	Form 990, Part III, Line 4d Other Program Services Description	OTHER PROGRAM SERVICES 4 The Post-Licensure Assessment System (PLAS) is a joint activity of the NBME and the Federation of State Medical Boards (FSMB) PLAS comprises two programs the Special Purpose Examination (SPEX) Program and the Assessment Center Program (ACP) SPEX is a one-day, multiple-choice examination of current knowledge requisite for the general, undifferentiated practice of medicine and is intended to be used for reasons of endorsement or reciprocity of licensure The ACP provides comprehensive objective and personalized assessments of physicians for whom there is a question regarding clinical competence Together, the PLAS programs have assessed thousands of physicians over the past decade for reasons that range from endorsement of licensure to license reactivation after disciplinary action NBME's International Programs unit provides students, graduate physicians, medical schools, and regulatory agencies with valid and reliable information regarding individual knowledge and overall curriculum effectiveness The International Foundations of Medicine (IFoM) program comprises a portfolio of consultative, faculty and institutional development, and examination programs The cornerstone of the program is the IFoM Clinical Science Examination (CSE) More than 7,000 students or graduates of 60 medical schools in 11 countries on 5 continents have taken the examination since 2007 The NBME international portfolio also includes on-site evaluation of overall assessment capability for medical schools, customized assessment services, discipline-specific, end-of-course examinations, progress testing, residency selection examinations, and national licensing examinations The International Programs unit is also involved in various research projects related to the validity and reliability of various assessment tools The Assessment of Professional Behaviors (APB) was offered as an operational program to residency and fellowship programs in May 2010 Assessment of Professional Behaviors has a mission to improve professional behavior through a formative multisource feedback process Ten training programs signed up for the operational program, while 20 other residency and fellowship programs and six medical schools are participating in ongoing APB pilots in 2011 Research and Development Programs include the Center for Innovation and the Stemmler Medical Education Research Fund The Center for Innovation is charged with development of new products and services and exploration of new ventures that facilitate NBME's strategic vision and mission The Stemmler Medical Education Research Fund assists research in topics relevant to the mission of NBME and has supported 67 grant awards for a total of over \$5.3 million since 1995 In addition to these defined programs of research and development, each program area and service unit is charged to carry on a program of research and development relevant to the work of the program or unit, for example, development of new item formats for USMLE, exploring relationships between prior measures and certifying exam performance for our clients, developing new testing methods for clients These research and development activities result in the publication of dozens of research reports in scientific journals and presentations at scientific meetings each year Note The expenses reflected above do not include institutional indirect expenses
