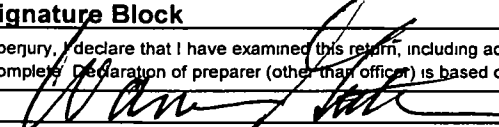
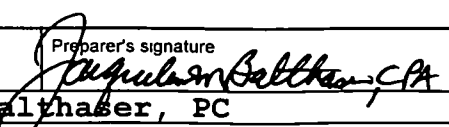

During the 2011 audit, the auditor became aware of several misstatements on the 2010 financial audit and the Form 990. The form 990 has been corrected in 2010 for the following errors:

- 1 - A pledge payable to the Jake Gittlen Cancer Research Foundation as of December 31, 2010 in the amount of \$402,684 was not recorded. The Tournament had contributed \$4,000,000 to the Jake Gittlen Cancer Research Foundation in November 2006. The Tournament continued to use those funds to pay their annual pledges. In 2010 the balance was miscalculated, and in 2012 when the pledges were re-evaluated for 2011, the error was found and corrected. The financial statements were restated for 2010 and we are also amending the 990 from 2010 to include this pledge payable.
- 2 - A contribution from the Stabler Foundation in the amount of \$50,000 was not a contribution made to the Tournament, but rather a direct grant to doctors at the JGCRF. The financial statements have been restated to remove the contribution from income and the offsetting contribution from expense.
- 3 - Schedule I - additional information had been ommitted from Part IV due to a software change that was not noticed.
- 4 - A General footnote has been added to explain the relationship and earnings of the President. This had been ommitted due to a software change.
