Multiple projects financed primarily by Earth Conservancy related to the reclamation and return of former coal company-owned land to the region, including the operation of a yard waste composting facility utilized by multiple Luzerne County municipalities. The facility processed approximately 9,000 tons of material, most of which will be utilized in land reclamation/improvement projects.

Remediation of acid mine drainage in Espy Run and at the Askam Borehole site. The acid mine drainage is a source of pollution for the Susquehanna River. In addition to the above expenses, primarily funded by grants, there was an additional \$38,819 in donated professional services relative to engineering design and supervisory services.

In addition to the distribution of the Conflict of Interest Policy, an annual written communication is distributed reiterating that a conflict of interest exists when an individual has a personal interest that may influence him or her when making a decision for the organization. Earth Conservancy believes that it is necessary to identify potential conflicts. For this reason, we periodically require that a written Declaration of

Affiliation is completed and retained for review by members of the Board of Directors, as necessary. Additionally, a written summation of family or business relationship among officers, directors or key employees is obtained.
