34 local programs were supported by grants through a competitive grant process of proposal and presentations to 40 volunteers from our community that made the final decisions. Donor Option Funds include donations designated by our donors to specific non-profits of their choice. Recruitment, training and support of the volunteers for the review process as well as training, accountability, and oversight of agencies receiving funds are important parts of making sure donations have the MOST impact in our community.

Community Building Activities: United Way staff and volunteers participate, plan, lead and support various events and activities in our communities in conjunction and collaboration with many other non-profits and government agencies. These activities promote healthy lifestyle choices for our citizens and address issues within our community.

Zenith Youth Leadership Academy, an 8 month facilitated leadership program for 7th & 8th graders provided mentoring leadership skills and confidence building activities to 20 youth.

Day of Caring project for 2010 was to finish out the interior of Portales Dream Center (a clothing, household and food distribution center). Project took six months and over \$60,000 in donated labor and materials and the work of 150 volunteers.

Worked with community leaders to address the lack of recreational activities for children, as a result YMCA opened a branch in Clovis.

Provided free health screening and educational seminars at Health & Wellness Day Event.

2-1-1 Information Helpline for residents of Curry & Roosevelt Counties. Assisted 1323 callers, produced a printed directory (Summer Youth Activity Guide) which was distributed for free to every elementary school child in two counties, convened bimonthly interagency meetings to strengthen collaboration between local agencies, and maintained a database and website of local, state and national resources.

In addition, through a generous donation, heaters were supplied to 38 families without heat in their homes.

During the summer months, electric fans were collected and distributed to 80 low income families.

Distributed over 500 Prescription Discount Cards and over \$23,000 was saved by local families.
