	MEDICALFAMILY PRACTICE INCLUDING SPECIAL PROGRAMS FOR AT RISK POPULATIONS, FAMILY PLANNING, PRENATAL AND PEDIATRICS SOUTHSIDE COMMUNITY HEALTH SERVICES, INC (SCHS) IS A 501 (C) 3 NONPROFIT ORGANIZATION AND IS A FEDERALLY QUALIFIED HEALTH CENTER (FQHC), LOCATED IN SOUTH MINNEAPOLIS SCHS HAS TWO MEDICAL CLINICS IN MINNEAPOLIS, ONE MEDICAL CLINIC IN STILLWATER AND ONE DENTAL CLINIC IN MINNEAPOLIS WHILE THE MAJORITY OF PATIENTS COME FROM THE SOUTHSIDE OF MINNEAPOLIS, SCHS DRAWS PATIENTS FROM THROUGHOUT THE TWIN CITIES METROPOLITAN AREA (PATIENTS CAME FROM OVER 74 ZIP CODES) SCHS HAS HAD AN ESSENTIAL COMMUNITY SAFETY NET PROVIDER DESIGNATION FROM THE STATE OF MINNESOTA SINCE 1997 FINALLY, SCHS DOES NOT DISCRIMINATE AGAINST ANY PATIENT BASED ON RACE, COLOR, NATIONAL ORIGIN, DISABILITY, RELIGION, SEXUAL ORIENTATION, AGE, OR ABILITY TO PAY IN 2010, OUR CLINICS SERVED MOSTLY LOW INCOME AND UNDER-SERVED WOMEN, CHILDREN AND FAMILIES THESE 10,921 PATIENTS GENERATED 32,367 CLINIC VISITS IN ADDITION TO THE CLINIC VISITS, OUR OUTREACH ACTIVITIES NOW KNOWN AS Q HEALTH CONNECTIONS, REACHED ANOTHER 10,000 RESIDENTS THROUGH LOCAL HEALTH FAIRS, A VARIETY OF PROGRAMS, AND OTHER COMMUNITY EVENTS Q HEALTH CONNECTIONS PROVIDES MUCH NEEDED HEALTH EDUCATION AND HEALTH AWARENESS TO MINORITY POPULATIONS SUFFERING DRAMATIC HEALTH OUTCOME DISPARITIES IN 2010, THE UNINSURED GREW FROM 38 2% TO 45 4%, A RECORD HIGH AT SCHS PRIMARILY CAUSED BY THE ECONOMIC RECESSION AND CONCOMITANT UNEMPLOYMENT WITH ITS ATTENDANT LOSS OF HEALTH INSURANCE COVERAGE CUTBACKS IN MEDICAID, FURTHER RESULTED IN DIMINISHED REVENUE TO THE CLINICS, BOTH IN MEDICAL AND DENTAL THE RESULT OF THIS CAUSED A SHORTFALL IN OPERATING REVENUES, NECESSITATING SOME LAYOFFS AND OVER \$1 2 IN BUDGET CUTS TO THE EXTENT POSSIBLE THESE UNINSURED PATIENTSWERE PLACED ON A SLIDING FEE BASED SCHEDULE 53 1% OF PATIENTS WERE COVERED BY PUBLICLY SUBSIDIZED INSURANCE SUCH AS MNCARE, MEDICAID, SCHIPS AND GENERAL ASSISTANCE MEDICAL CARE (GAMC), AND 9 4% WERE PRIVATELY INSURED IN 2010, WE EXPECT AN EVEN GREATER PROPORTION OF UNINSURED DUE TO GAMC BEING REDUCED BY TWO-THIRDS AND THE REMAINING ONE-THIRD GOING EXCLUSIVELY TO HOSPITALS THAT WILL REMOVE ANY GAMC PAYMENTS TO CLINICS IN 2010, 71% OF OUR PATIENTS WERE AT OR BELOW 200% OF FEDERAL POVERTY LEVEL IN 2010, SCHS PATIENT CASELOAD REPRESENTED 33 1% CHILDREN AND TEENS AND 66 9% WERE ADULTS 58 1% OF PATIENTS WERE FEMALE, 41 9% WERE MALE 23 2% OF PATIENTS WERE BLACK/AFRICAN-AMERICAN, 38 8% WERE HISPANIC/LATINO, 2 8% WERE ASIAN, 0 5% WERE AMERICAN INDIAN 37 5% WERE NON HISPANIC WHITE AND 1 1% WERE OTHER THE 2010 PATIENT CASELOAD CAME FROM 74 DIFFERENT ZIP CODES IN 2010, 32 6% OF SCHS PATIENTS WERE IMMIGRANTS, MANY WITH LIMITED ENGLISH SPEAKING ABILITIES AND LITERACY LEVELS, 37 PATIENTS WERE CLASSIFIED AS HOMELESS AND 24 PATIENTS WERE MIGRANTS/SEASONAL WORKERS IN CONCLUSION, WHILE SCHS HAS LONG SERVED THE POOR AND HISTORICALLY DISENFRANCHISED POPULATIONS WITHIN THE COMMUNITY FROM 2008-2010, SCHS BEGAN TO SEE THE NUMBERS GROW IN THE UNINSURED AND UNDER INSURED RANKS DUE TO THE UNFORTUNATE IMPACT OF THE ECONOMIC RECESSION AND ITS CONCOMITANT UNEMPLOYMENT WE FULLY EXPECT THE UNEMPLOYMENT PICTURE TO BE A LAGGING INDICATOR FOR SOME TIME TO COME THEREFORE, 2011 WILL PROBABLY BE A CONTINUATION OF REDUCED CLINIC INCOME UNDERSCORING THE ADDITIONAL NEED FOR OUTSIDE GRANTS AND OTHER ASSISTANCE
