### Part III, Organization's Primary Exempt Purpose:

Birthright of Greater Hartford, Inc. offers services, aid and assistance to individuals who have problems with a pregnancy and desire a positive alternative to abortion.

#### Part III, line 28:

Birthright's volunteer staff also offered community resource information and referrals. Estimate (from previous year): 578 total callers. Of these, 87 community assistance callers and 491 crisis pregnancy callers.

Pregnancy testing provided for 221 women and friendship counseling for 359. 114 babies born to mothers we served. 72 mothers received maternity clothing and 81 babies received baby clothing.

Actual (not estimated): 36 mothers assisted in purchasing cribs and 33 in purchasing car seats. Friendship counseling volunteers staffed the office 41 hrs/wk and clerical and clothing volunteers 24 hrs/wk. Grant of \$8000 to Birthright U.S.A. hotline which is staffed 24 hrs/day, 7 days/wk.
