In September 2009, I was elected treasurer of Camp Sunlight, Inc. at that time we were not aware of the changes in the tax law that non profits with revenue of less than \$25,000 per year would need to file.

In the spring of 2010 I learned of the changes from a newspaper article and filed electronically for 2009. In addition I filed electronically for 2011 and 2012.
