Working in Tobacco Control: Indiana Latino Institute Inc (ILI) leads the Indiana Latino Tobacco Control Coalition (ILTCC) that consists of state wide partners in Hamilton, Lake, Marion, St. Joseph, and Tippecanoe counties performing various levels of outreach in prevention, education, advocacy and cessation in tobacco control.

Working in HIV/AIDS: "Woman to Woman" is a program which educates and informs women about HIV/AIDS, and other STD's (sexually transmitted diseases), domestic violence and other issues.

Working in Nutrition: Fathers, Grandfathers and Uncles in Action (P.A.T.A.) is a program which targets Latino's ages 12-17 and their family through participation in soccer leagues and offers them presentations to increase awareness and motivate behavioral changes in eating habits and physical activity.
