On December 15, 2008, the J R Albert Foundation entered into a settlement agreement and release of claims ("Settlement Agreement") resolving certain claims and disputes with the J R Albert Charitable Trust. The settlement agreement was conditional upon the Attorney General of Texas and the Attorney General of Missouri, respectively, not posing any objections to its terms and conditions. The settlement agreement was subsequently presented by the parties to the Attorneys General shortly after its execution date. Neither the Attorney General of Texas nor the Attorney General of Missouri posed objections to its terms and conditions. As a result, a payment of \$6,000,000 was made by the J R Albert Foundation to the J R Albert Charitable Trust under the settlement agreement in 2009. An additional \$32,963 in expenses attributable to this settlement were paid in 2010.



## **EXHIBIT A**

### **Resolution**

NOW THEREFORE BE IT RESOLVED, that Section 3.4 of the Bylaws be deleted in its entirety and in lie there of the following Section 3.4 be inserted:

#### **Section 3.4. Election and Terms of Office**

(a) There shall be two (2) classes of directors, identified respectively as Class A and Class B;

(b) There shall be three (3) Class A directors, each of whom shall be appointed for terms of five (5) years. There shall be two (2) Class B directors, each of whom shall be appointed for terms of one (1) year

Each director named shall hold office until the term of office of such director's successor has commenced; or until such director's earlier death, incapacity, disqualification, resignation or removal. Any director may be elected for successive terms.

After the election of the new members of the Board of Directors, the meeting shall continue as a meeting of the new Board for the purpose of electing officers and transacting such other business as may be presented to the meeting, and no notice need be given to such newly elected directors who are present at the meeting or who sign waivers of notice.
