The mission of the GO Fund is to provide vulnerable women and children in Africa with opportunities to permanently lift themselves out of poverty. We implement innovative programs using our signature "L.E.T.S. GO!"™ strategy - which provides women and children with opportunities to Learn, Earn, Thrive and Survive.

The GO Fund's SEW FOR SISTERHOOD program began as a vocational training program and has since transformed into a viable business cooperative in Ghana. The GO Fund has trained over 50 women in Ghana in the trades of sewing and batik. Additionally, the women have tapped a strong market for locally made clothing, designing and filling orders for school uniforms and creating custom clothing for Expats and tourists.

Through the GO Fund's GIFT-A-GOAT program, donors can "gift" a milk goat to a family in Africa, thereby directly impacting their health and economic well-being for years to come. The GO Fund has gifted over 100 goats to families in Africa.

Through our LOANS FOR A BETTER LIFE program, we distribute low-interest microcredit loans to women entrepreneurs who then repay the funds with the profits they generate from their small business.
