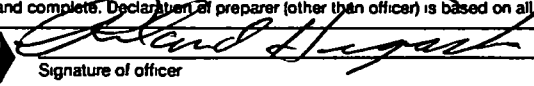

In 2010, The Food Basket received approximately 1.45 million pounds of food from 39 corporate donors, community donors and the USDA. More than 1.25 million pounds of food was distributed to 84 partners. 876,679 duplicated individuals were served. The Food Basket saw a 41.55% increase of persons served over 2009. The Senior Brown Bag program distributed food to 554 seniors, thus providing approximately 88,640 pounds of food. The Senior Farmers Market Program distributed fresh produce to 1,771 low income seniors island wide over a 15 week period. Approximately 265,650 pounds of produce was distributed. □□□□□□
