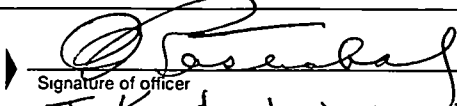

PART III

The organizations purpose is to offer non-reimbursable tuition payments for full and parttime employees of Vi at the Glen (formerly Classic Residence by Hyatt) These payments are made directly to the university college or any other type of school, but not to the employee directly.

During the calendar year 2010 approximately \$ 96,445 was awarded to various employees - paid directly to the schools for tuition and books.
