By not just giving them a hand out but a hand up we hope to provide them with the opportunity to become responsible and caring adults who will take the love of Christ to all nations. We are a 501(c)3 non-profit organization, dedicated to serving children in need throughout the world.

Sponsorship also helps supports the Makrias Christian School which currently includes baby class to grade 8 with over 300 vulnerable children enrolled. We sent 8 people to Kenya. These men and women served the Lord by holding VBS for over 270 children (ages baby class through grade 6). The team hiked into the bush to visit widows in need, they ministered in a new church and through door-to-door evangelism, plus, they help to, repair the childrens center, and refinished the children's desks. The Team got to be the hands and feet of the Lord to the children of the school and childrens center, staying at the center and living with the children and staff.
