The Museum facilities are used by Ohio Hi-Point Vocational School, Urbana, Ohio, to support the School's Aviation Occupations Program. The program is provided free use of the museum's facilities, equipment, and tools. During tax year 2010, seven (7) students completed the Program.

Public Use of Museum Facilities

During tax year 2010, the Museum facilities were open to the general public from Monday through Saturday of each week (except legal holidays) between 9:00 am and 4:00 pm. During tax year 2010, the Museum had approximately 1,500 public visitors.

General Public Volunteer Participation

The Museum relies on volunteers to restore and maintain its aviation fleet and to operate the Museum. During tax year 2010, 92 volunteers provided an aggregate of 24,000 hours of volunteer work. No compensation was paid to the volunteers. Some volunteers maintained, at their own expense, certification with the Federal Aviation Administration to perform some of the aviation restoration and maintenance functions.
