Out of these revenues \$8,105 were distributed in the calendar year 2010 as scholarships to students in Sri Lanka to help them further their education. Other expenses mainly include fund-raising expenses and operating expenses. Because of a delay in a scholarship payment, which was physically rendered in the calendar year 2011 which belonged to 2010, and a substantial grant through a competition, a high positive fund balance was reported for the calendar year 2010.
