Movement of Youth is a comprehensive educational and mentoring program built to expand educational opportunities for diverse high school students in the Durham Public Schools System. Movement of Youth encourages students, who have demonstrated academic promise, to pursue higher education. Movement of Youth provides three primary services during the school year: Team Mentoring, Saturday Academy, and Community Outreach. Through this dynamic design, participants receive intellectually challenging workshops, positive role models to help set long-term aspirations as well as the mentoring support required to nurture and fulfill those aspirations. Our mission is to prepare our youth to lead and succeed in the 21st Century by enriching, engaging, and empowering them through mentoring and targeted programming. Our investment in diverse high school students is an investment in America's future.

28	Team Mentoring is the cornerstone of Movement of Youth. College students apply annually to become mentors and friends for high school students in the Movement of Youth program. These close, multi-year relationships provide participants with access to a college scholar who offers knowledge about how to successfully apply to and excel in college. The goal is to promote the academic achievement of the participants, motivating them to complete high school and then pursue higher education. The program offers activities that support these goals and relationships between mentors and mentees. Saturday Academy is held twice a month and features a variety of sessions built to challenge participants in different ways: intellectually, physically, and socially. Sessions are tailored to address the complex issues that diverse youth face daily while also providing opportunities for individual growth and professional development. Sessions focus on the following areas: Life Skills, Education, Health, The Arts, Business, Science & Technology. By attending these sessions, students will gain the tools necessary to excel in a variety of different situations. Movement of Youth seeks not only to help students reach success, but also to instill in students the importance of giving back to others. Community Outreach allows participants to have a positive impact in the community by completing two Community Outreach initiatives each year. Examples include: UNC Dance Marathon. Students participate in an all-night dance to raise money for children at the UNC Children's Hospital. Martin Luther King Day of Service. Students participate in MLK Day of Service activities. Steps for Health-A Walk for Breast Cancer. Students participate in a 3.1 mile walk to raise money for Breast Cancer Research. Our Community Outreach initiatives allow participants to use their talents to become instruments of change in society. Movement of Youth hosted 20 Saturday Academy Sessions and 2 Community Outreach Sessions in 2009 - 2010 and impacted over 150 students through Mentoring.
