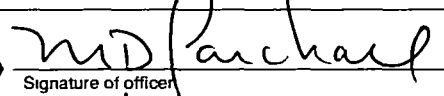

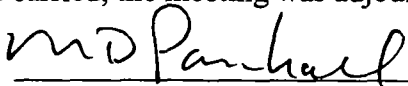
The approved changes will be filed with the State of Texas and the United States IRS will be notified subsequently when the IRS form 990 is filed in 2011.

There being no further business to come before the board, upon motion, duly made and seconded, and carried, the meeting was adjourned.

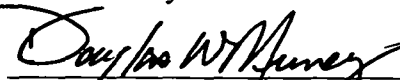
