During 2009, GBBMI raised and provided funds to Global Banjara Baptist Ministries
(GBBM) for the completion of the Aletheia Banjara School in Gurrapu Thanda, India.

The school educates and feeds 246 Banjara children from 21 villages in the region.

The children range in age from pre-kindergarten through the fifth grade, are
taught by eight teachers and are supported by a principal and one administrator.

Comments from parents about the difference that the school is making in the lives
of their children:

From the parent of a second grade student: My husband and I are so grateful to
the school management for opening the school in the area where it is. We could
not have sent our son to any town because he has difficulty while he walks.

Because the school is located in our village, we can send him. He is learning
lots of things, the most thrilling of them is to see him reading and speaking
English. We are so proud of him.

From the parent of a first grade student: We appreciate all the other things and
are very happy that lunch is provided at school. Our daughter eats well at the
school and stays healthy. She used to fall sick frequently, but not now. We
thank the organization for thinking of this.

During 2010, GBBMI supported the drilling of a new well and the installation of a

water filtration system to provide drinking water to the school. Funds were also raised to construct seven additional latrines and to provide scholarships for students to attend the school.

A missionary group from Fellowship Bible Church in Waco, Texas traveled to India during 2010. In addition to helping to train Christian ministers, the group conducted a medical camp at the school. Each child received a medical examination and vitamins, and the church donated a wheel chair to the school for general use.

GBBMI continued to sponsor six micro-businesses in the region. These businesses include two grocery stores, one goat herd, two buffalo milking operations and one grain grinding operation.
