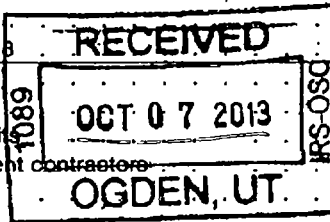

EXPLANATION FOR AMENDED RETURN:

THIS AMENDED RETURN IS BEING FILED BECAUSE THE TAXPAYER'S EXEMPT STATUS WAS REVOKED IN FEBRUARY OF 2011 DUE TO
NON-FILING OF THE REQUIRED EXEMPT ORGANIZATION RETURNS FOR THREE CONSECUTIVE YEARS. THE TAXPAYER THEN FILED
THE EXEMPT ORGANIZATION RETURNS FOR 2008 THROUGH 2011 ANYWAY IN AN EFFORT TO GET IN COMPLIANCE. ONLY AFTER
THESE RETURNS WERE FILED DID THE TAXPAYER REALIZE THAT THEY WERE REQUIRED TO FILE FORMS 1120 FOR THESE YEARS AND
NOT FORMS 990. SO THE TAXPAYER IS NOW FILING AMENDED FORMS 990 FOR THE YEARS 2008 THROUGH 2011 SINCE THEY SHOULD
