2. An Amendment to the Corporation's Articles of Incorporation was adopted by the Board of Directors on January 11, 2010.
3. The Amendment as adopted is as follows:

RESOLVED, that Article 5 of the Articles of Incorporation of the Kenneth F. Churchill and Eugenia M. Churchill Foundation, Inc, a Missouri Not For Profit Corporation, be amended so that Article 5 of the Articles of Incorporation of the Kenneth F. Churchill and Eugenia M. 
