During 2010 the scholastic component of A Better Day Learning Center, Inc. was still being established in order to provide the highest quality preschool education for children with Autism and Developmental Disabilities. This is mainly due to lack of funding through private sectors and inability to prepare effective fund raising campaigns. The therapeutic component for the organization has continued to progress. In 2010 there were 5 patients under CDC for which independent contractors were compensated for their work with these patients. Local events were attended in order to promote the services provided by the agency as well as educate parents and caregivers on the available services within the community. ABA therapy was explained to parents and caregivers and we were able to assist some parents in obtaining or determining their eligibility for insurance coverage to receive services. Information packets were prepared and distributed during all of these events as well as items given to children which assist in their therapy sessions.
