Children's Home and Cyclone Nargis Orphanage -- We currently have a total of 72 children in our safe home and orphanage, in which we are financially responsible to clothe, educate, feed and provide all medical and personal needs We serve at-risk, abused, exploited and abandoned children and are responsible to provide safety, shelter, love and hope for their future, in the form of education or a vocational trade In order to run the safe homes and orphanage we employ 10 full time workers The duties that entail raising and supporting 72 children are as follows, transportation to and from school, mass cooking and bi-weekly market runs, washing all of their clothing, cleaning and sanitizing the safe home regularly, regularmedical appointments and check-ups, continually liaising with the children's schools and teachers We also have special art, English and tutor programs for the children Regular outings and holiday celebrations are held for the children We see the children through school until they obtain a degree or specialized vocational training to ensure their future and so they will be a productive member of society

Babies Home -- We currently have 14 abandoned babies We are fully responsible for all of the babies needs such as, milk, diapers, and medical We assign one care-giver to every baby, until they are 2 or 3 years old, depending on each case We also provide an onsite preschool/day care until the baby is old enough to attend school We have a total of 20 staff for this project, one for each baby and 5daycare, cleaning and cooking staff Some of our babies come to us malnourished and sick so we nurse them back to health and have regular doctor appointments for them, and give them all the love and attention that they need in the crucial first years of their life so that they develop properly We focus on motor skills at every age and have trained staff that looks for developmental alarms or hindrances

Emergency Shelter -- This program is for at-risk women, where we give women an alternative vocation for income instead of selling themselves or their children These women are otherwise at-risk of exploitation, abuse and prostituion We provide shelter, food and clothing for these women and their children until they can support themselves and their children We currently have 4 staff for this home and train the ladies how to sew purses as a means of income The women and young girls are also taught life-skills and emotional management, as well as provided daycare and supplemental support for their children They attend all activities with us and their children attend our daycare
