☒ **STATEMENT 1 - ORGANIZATION'S PRIMARY PURPOSE**

Feeding Pets of the Homeless is an all-volunteer member organization that provides pet food and veterinary care to pet belonging to the homeless and less-fortunate in local communities across America. Our member collection sites collect pet food and supplies then deliver it to food banks, soup kitchens, homeless shelters which have agreed to distribute the pet food. We award grants to licensed veterinarians who perform free wellness clinics and provide veterinary care to pets of the homeless. Grant applications are available upon request. No deadlines.

Without our help, many homeless would have to turn their pets over to overcrowded animal shelters. Without our help, the homeless would lose the one thing that brings them comfort, unconditional love without judgment, and sometimes security on the streets. Their pets give them purpose with the daily challenge of providing food, water and shelter, which in some cases keep these people from going over the edge of reality.
