

28- Part III TWC's primary service vehicle is the Connections Program—a strategic intervention designed to supplement and complement the efforts of area foster care agencies with financial planning, career planning and workforce readiness skills as well as mentors, youth groups and transitional funding. After one year of operation, the Connections Program is already showing some early indications of success. We've directly served over 40 youth in foster care in South Hampton Roads and indirectly served over 300 through our teen newsletter and support of foster care youth events. The youth we are working with are beating national odds for foster youth. According to national statistics we should be seeing a 25% high school dropout rate. Our youth are showing a 3% dropout rate. National averages indicate that 84% of foster care youth will not have held any job by the age of 24. 50% of our youth have already found part-time employment and 30% found that employment after taking our Life-Work Portfolio Class where they practiced and refined their interviewing skills. National statistics indicate that fewer than 6% of foster youth will have a 2- or 4-year college degree by the age of 24. 100% of our high school graduates are pursuing or have completed some form of higher education or vocational training. In addition to the Connections Program, TWC convened a working group of area agencies to explore and design better housing options for youth who age out of foster care.
