This return was due on May 15, 2011. In early 2011, the organization transmitted its relevant records to a CPA to prepare the same. Later, when the organization inquired as to the status of the 2010 return, the CPA indicated it had been filed. This year, when the organization inquired to the CPA about preparing the 2011 return, the organization simultaneously requested the CPA provide the organization a copy of the 2010 return. At that time, the CPA informed the organization that the 2010 return had inadvertently not been filed. Upon learning of this mistake, the organization prepared this return to correct the error. This error was unintentional. The organization has complied with all other filing and tax payment requirements and intends to fully comply with all ongoing requirements. Accordingly, the organization requests a one-time waiver of any late fees and/or penalties.
