WE WANT TO PROTECT THOSE WHO HAVE BEEN TRAFFICKED THROUGH THE PROVISION OF CRISIS SHELTERS AND TRANSITION HOMES AND AIM TO GIVE THEM EDUCATIONAL AND VOCATIONAL OPPORTUNITIES TO IMPROVE THEIR ABILITY TO WORK IN MORE MEANINGFUL EMPLOYMENT. ALL OF THIS IS DONE THROUGH PARTNERSHIP WITH OTHER ORGANIZATIONS SUCH AS, POLICE, OTHER LAW ENFORCEMENT AGENCIES (LEAS), IMMIGRATION, BORDER CONTROLS, EMBASSIES/CONSULATES AND OTHER NON GOVERNMENT ORGANIZATIONS. THE ANTI-TRAFFICKING POLICE DEPARTMENTS IN GREECE MADE THE A21 CAMPAIGN THE FIRST ORGANIZATION TO BE CONTACTED WHEN A CASE OF HUMAN TRAFFICKING IS FOUND WITHIN OUR AREA OF HELP.
