medicines to 1,700 patients and distributed vitamins and parasite
medications to 3,300 people. They hosted childrens programs for 3,500
children. They installed 100 water filters to provide clean water to
4,000 people and distributed 35,000 lbs of food.

Scholarship Program - In Kenya public school is provided through 8th
grade, students must then find a way to pay for a high school education.
Many families cannot afford the cost of high school, so Expansion
International provided scholarships to 35 children for a year of high
school which includes meals, uniforms and supplies. This education
will enable these children the ability to be employed and the option
to make good life choices to live fulfilling productive lives.

Kieni Resettlement Program - This is a refugee camp from tribal violence
that houses over 800 families (over 4,000 people) in 13 x 13 temporary
shelters. These families need to be resettled as they have been in

working to raise the capital and develop a model for resettlement.
In 2011 work will commence on the acutal resettlement of families.
