Jama-Coaque Ecological Reserve for conservation.

Part II, Line 26: \$70,500 in Total Liabilities includes a debt \$23,500 to each of the three officers of Third Millennium Alliance for the balance

of their 2010 salary. As stipulated in the organization's bylaws, each of the three officers shall receive an annual salary of \$40,000,

however the organization was only able to pay each of the three founding directors \$16,500 for services rendered in 2010. The balance of

\$23,500, multiplied by three, yields the Total Liabilities.

Part IV: As stated above, each of the officers (C.E.O., Treasurer, and Secretary) were only paid \$16,500 out of the \$40,000 salary

stipulated in the bylaws.
