Africa Windmill Project worked in the villages of Mgowayi, Mzumala, Mtandire, Mziza, Kduwa and Chibanzi in 2010 focusing on teaching sustainable agriculture techniques (composting, soil conservation, crop management) which lead into irrigation. AWP provided education and support for 5 water pumps including 1 windmill. The pumps were installed 1 in each village (except for Mzumala) and utilized in 4 of the villages for garden irrigation. The farmers were supported throughout their multiple growing seasons to adapt their garden to trench irrigation and support for pump repair and utilization. AWP has received great response from 2 of the 4 villages and has requests to educate and support the farm communities in those villages the new irrigation technology that they saw utilized by the single farmer in 2010. AWP has also made contact with Malawian government and local community based organizations that could benefit from sustainable agriculture and irrigation. AWP attended the United States conference at ECHO (educational concerns for hunger organization) to learn what other NGO's are doing in the sustainable agriculture field and to share the irrigation technology with those organizations. Approximately 1360 volunteer hours were contributed for the running and operational expenses of this program.
