This is a shared services infrastructure for the early childhood education sector to promote effective governance, high standards of program quality, professional competence, operational efficiency, as well as financial sustainability. The objective is to strengthen overall business operations, and allow the child care providers to spend more time in the classroom. ELV provided support and oversight to its partners while continuing to research and develop the model and policies. This effort involved ELV staff providing technical assistance, business planning, and resource development. There are currently Alliances launched in Colorado Springs, Arapahoe County, and Broomfield. More are under development in the Denver area and Summit County.	524,250
2 ELV created a customized web-based information management system for the Early Learning Ventures Alliance model. The Child Management System includes educational performance and accountability data management software, professional development supports, and financial management functionality.	133,001
3 Healthy Options for Preschoolers.
