For the purpose of forming a not for profit corporation under the laws of the State of Kansas, the undersigned natural person of the age of eighteen years or more adopts the following Articles of Incorporation:

ARTICLE I
NAME OF CORPORATION

The name of the Corporation is PIPELINE INC.

ARTICLE II
REGISTERED AGENT

The name and street address of its initial Registered Agent and Registered Office in Kansas are: CT Corporation System, 515 South Kansas, Topeka, KS 66603.

ARTICLE III
INCORPORATOR

The name and address of the Incorporator is Joni Cobb, 8527 Bluejacket Street, Lenexa, KS 66214.

ARTICLE IV
STOCK; MEMBERSHIP

The Corporation will NOT have authority to issue capital stock. The Corporation shall have members. The members shall be the directors serving on the Board of Directors.

ARTICLE V
BOARD OF DIRECTORS

The Board of Directors shall manage and direct the management of the affairs of the Corporation. All corporate powers shall be exercised by or under the authority of the Board of Directors. The number of directors constituting the initial Board of Directors is one. The name and address of the initial directors is Joni Cobb, 8527 Bluejacket Street, Lenexa, KS 66214. The initial Board of Directors shall serve until a successor is elected and qualified. Thereafter, the number, term and election of directors shall be as provided in the Bylaws of the Corporation.

ARTICLE VI
NO PERSONAL LIABILITY FOR
CORPORATE DEBTS, LIABILITIES OR OBLIGATIONS

The directors, officers and members of the Corporation shall not be individually or personally liable for the debts, liabilities or obligations of the Corporation.

ARTICLE VII
PURPOSES

The Corporation is organized and shall be operated for the following purposes:

- (a) To foster the development of high growth entrepreneurs in Kansas through the development of education, peer networking, mentorship and a more connected dynamic entrepreneurial environment in Kansas;
- (b) To encourage the attraction of capital and investment expertise into the State of Kansas through the development of programs and opportunities within and outside of the State of Kansas;
- (c) To receive and accept contributions to the Corporation exclusively for charitable, educational and scientific purposes;
- (d) To hold and administer contributions to the Corporation exclusively for charitable, educational and scientific purposes;
- (e) To engage in similar charitable, educational and scientific activities; and
- (f) For any other lawful purpose under the laws of the State of Kansas, subject to the limitations of Article VIII.

Charitable, educational and scientific purposes and organizations are charitable, educational and scientific purposes and organizations within the meaning of the applicable laws of the State of Kansas and Sections 501(c)(3), 170(c)(2)(B), 2055(a)(2) and 2522(a)(2) of the Internal Revenue Code of 1986, as amended (the "Code"). Any reference in these Articles of Incorporation to an Act Section shall include the corresponding provision or provisions of any applicable future Kansas law and any reference in these Articles of Incorporation to a Code Section shall include the corresponding provision or provisions of any applicable future federal tax law.

ARTICLE VIII
REQUIREMENTS FOR AND
LIMITATIONS ON PURPOSES AND ACTIVITIES

The Corporation is organized and shall be operated exclusively for charitable, educational and scientific purposes within the meaning of the applicable law of the State of Kansas and Code Sections 501(c)(3), 170(c)(2)(B), 2055(a)(2) and 2522(a)(2). The Corporation shall not conduct any activities not permitted to be conducted by a corporation under the applicable laws of the State of Kansas and Code Sections 501(c)(3), 170(c)(2)(B), 2055(a)(2) and 2522(a)(2).

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to the directors, officers, members or any other person, except that the Corporation may pay reasonable compensation for services rendered and may make payments and distributions in furtherance of the purposes set forth in Article VII.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, except as otherwise provided by Code Section 501(h) and other applicable laws. The Corporation shall not participate in or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

If this Corporation is at any time a private foundation within the meaning of Code Section 509(a), then during the period in which the Corporation is a private foundation, the Corporation (1) shall distribute such amounts at such times and in such manner as not to become subject to tax under Code Section 4942; (2) shall not engage in any act of self-dealing as defined in Code Section 4941(d); (3) shall not retain any excess business holdings as defined in Code Section 4943(c) so as to become subject to tax under Code Section 4943; (4) shall not invest any amount in such a manner as to jeopardize the carrying out of any of its exempt purposes as defined in Code Section 4944; and (5) shall not make any taxable expenditures as defined in Code Section 4945(d).

This Article VIII shall apply strictly in accordance with its terms notwithstanding any other provision of these Articles of Incorporation.

ARTICLE IX POWERS

The Corporation shall have the power to do all things necessary or convenient to carry out its purposes, as may be described under the laws of the State of Kansas.

ARTICLE X BYLAWS

The Board of Directors shall adopt Bylaws for the Corporation for the purpose of regulating and managing the affairs of the Corporation in a manner not inconsistent with these Articles of Incorporation, the Act, the Code or other applicable law. The Board of Directors may amend the Bylaws at any time and from time to time upon the affirmative vote of at least two-thirds of the total number of directors.

ARTICLE XI DURATION

The period of duration of the Corporation is perpetual.

ARTICLE XII DISSOLUTION

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, distribute all of the

assets of the Corporation to one or more organizations organized and operated exclusively for charitable, educational or scientific purposes as shall at the time qualify as an organization or organizations described in Code Section 501(c)(3). Any assets not so disposed of shall be disposed of by the court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively to such organization or organizations described in Code Section 501(c)(3) as such court shall determine.

ARTICLE XIII
ARTICLE AMENDMENTS

The Board of Directors may amend these Articles of Incorporation at any time and from time to time upon the affirmative vote of at least two-thirds of the total number of directors.
