Inland Northwest Honor Flight conducted 6 Honor Flight Trips from Spokane to Washington DC in 2010. The trips occurred on April 30th to May 2nd, June 10th-12th, July 7th-9th, August 8th-10th, Sept. 10th-12th, and October 30th-November 1st. These trips are the sole focus of our organization. Each trip we took veterans to the memorials in Washington DC at no expense to the veteran. All of the veterans we took in 2010 were World War 2 Veterans. The trip is completely free for the veterans and covers round trip airfare, 2 nights lodging, all meals, and transportation on a chartered bus to tour the service memorials in the DC area.

990-EZ Part I Line 16 "Other Expenses"

These are expenses such as: the premiums on our liability insurance and Directors Insurance, Office Supplies, water and food for veterans who represented our organization at special events such as the Spokane Lilac Parade, renewal fees for the operation of our website/domain registration, Washington State non-profit organization fee, etc.

CORRECTIONS ON AMENDED RETURN

990-EZ LINE L---Gross Receipts were originally reported as \$151,017. A I neglected to include the \$242 dollars we received in 2010.

The correct figure was modified to \$151,259.

990EZ Part 1 Lines 1 and 9; 990EZ Sch A, Section A Lines 1E, 4E, and Section B Line 7E were changed to 151,259 for the same

reason as above. This changed the amount in Sch A Section A lines 1F and 4F and Section B lines 7F and 11F from \$221,213 to \$221,455.
