Page 2, Part III, Statement of Program Service Accomplishments

Primary Exempt Purpose: The corporation's purpose shall be (1) to promote community welfare on a local and international scale, (2) to enhance the development of economic and agricultural techniques, educational opportunities, community health and character development, (3) to work with individuals, non-profit agencies, foundations and churches to bring resources together for the enhancement and the development of communities, both locally and internationally, (4) through the practice of Christian principles, to care for and enhance the well being of others and, (5) to do all things and perform all acts permitted of a general corporation under the act.

Line 28 – Items A through C from Sch I are part of a program associated with the Oasis Training Center which teaches English and computer skills to students in rural northwest China. The graduates find employment at better economic levels than would be possible otherwise. An estimated 80 students annually benefit directly and several hundred benefit indirectly through a community center and orphanage. **\$ 17,664**

Line 29 – Item D from Sch I is a program allowing Matt Muse to study the Chinese language and culture. Over 200 people benefit yearly through his tutoring, as well as, programs that work with orphanages and marriage improvement seminars. **\$ 59,860**

Line 30 – Item E from Sch I was funds (\$20,000) to remodel a school building operated by Savior's tear in Managua, Nicaragua. The school provides education and two meals daily for approximately 400 children who live near the Managua city dump. Students and parents are severely economically disadvantaged. An additional grant of \$2,000 was provided to obtain hygiene packs (1000 @ \$2 each) to be distributed to victims of flooding in the area served by the school. **\$ 22,000**

Line 31- Item F from Sch I was funds to purchase veterinary medical supplies for students from Oklahoma State University to travel to Central America providing veterinary services to rural area farmers. Students also help in animal sterilization and vaccination programs. **\$ 553**

(and) Item G from Sch I was funds to purchase one case of books used in a classroom setting for Seattle Urban Academy. Seattle Urban Academy provides education for at-risk students in urban Seattle, Washington. **\$ 300**
