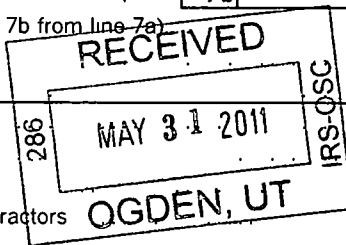

The Boomerang Foundation has the following broad goals: 1) Help teens build self-confidence as they see that their individual and collective community service projects can have a positive, direct impact on communities; 2) Raise awareness among teens about issues and people outside their own immediate experience thus enhancing their ability to identify and creatively address emerging community needs; 3) Empower teens to connect with the nonprofit sector as strategic partners; and 4) Engage and encourage parents, educators and other adults to support the community service efforts of young people.

Lasting social change must include and be led by the next generation: the Compassion Generation.
