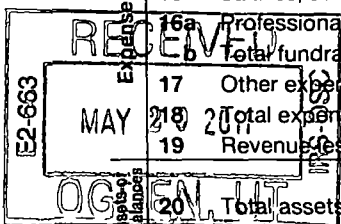

During this trip over 300 eye exams were conducted, 300 pairs of prescription eyeglasses were distributed, and an elementary school was painted. Also in 2010 a mobile surgical unit was purchased for future medical trips. This unit, along with many other health supplies, living supplies, mobility aids, and construction supplies were loaded into two 40 foot containers and shipped to Cote d'Ivoire in preparation for our primary annual trip which occurred in February 2011.
