10. A GRANT IN THE AMOUNT OF \$2,124 WAS MADE DIRECTLY TO THE TUMIANI ORPHANAGE IN NYERI KENYA TO PURCHASE CHICKENS. THINK KINDNESS RECEIVED PHOTOS AND CONFIRMATION THAT THE FUNDS WERE USED FOR THIS MANNER. CHICKENS PROVIDE LONG-TERM SUSTENENCE TO THE KIDS AT THE ORPHANAGE.

16. OTHER EXPENESES OF \$24,085 CONSIST OF \$21,066 FOR TRAVEL EXPENSES PRIMARILY RELATED TO THE TRIP TO KENYA. \$2,984.9 FOR PAYROLL TAXES AND LICENSE FEES MADE TO EITHER THE NEVADA STATE GOVERNMENT OR THE FEDERAL GOVERNMENT IN RELATION TO OBTAINING 501(C)3 STATUS.

20. THE BANK ACCOUNT USED WHEN THINK KINDNESS WAS FORMALLY BEGINNING IN MARCH OF LAST YEAR HAD \$457.26 IN THE ACCOUNT FROM BRIAN WILLIAMS (PRESIDENT). INSTEAD OF CLAIMING THAT AS "REVENUE", I BOOKED IT AS THE OPENING BALANCE EQUITY IN QUICKBOOKS WHEN ESTABLISHING THE CHART OF ACCOUNTS AND THE BEGINNING LEDGER BALANCES.

24. A BALANCE IN OTHER ASSETS OF 2,170.70 IS A DEFERRED EXPENSE RELATED TO BRIAN WILLIAMS REIMBURSEMENT FOR THE 2010 GLOBAL ACT OF KINDNESS TRIP TO NYERI KENYA. HE PAID FOR HIS TICKET OUT OF HIS OWN FUNDS AND ONE MILLION AOK WAS TO REIMBURSE HIS TRAVEL TICKET FROM REVENUES RECEIVED FROM THE DOCUMENTARY WHICH WAS TO BE PRODUCED OVER THE NEXT YEAR OR MORE. IN ORDER TO ADHERE TO GAAP AND MATCH THE EXPENSE IN THE PERIOD IN WHICH THE REVENUE WAS EARNED, THE EXPENSE WAS DEFERRED AND A CORRESPONDING LIABILITY PAYABLE TO BRIAN WILLIAMS WAS BOOKED.

26. TOTAL LIABILITIES CONSISTS OF THE \$2,170.70 DEFERRED EXPENSE DESCRIBED IN NUMBER 24 ABOVE. AS WELL AS \$1,718 IN PAYROLL TAX LIABILITY THAT WAS PAYABLE AT BALANCE SHEET CUT OFF DATE BUT PAID IN THE NEXT FISCAL PERIOD (JAN). THERE WAS A \$600 LIABILITY PAYABLE TO CAL WILLIAMS AS HE PAID FOR AN EXPENSE ON BEHALF OF ONE MILLION AOK FOR A FUNDRAISING EVENT AND THE CUP PURCHASES FOR "THE ZOMBIE CRAWL".
