This Employment Enhancement Opportunities Program provided paid employment & training to 28 people in 2010. These participants were referred to the program from Adult Probation due to re-entry after incarceration, from our 10 Not-for-Profit agencies and from our local substance abuse recovery centers. In 2010, 22 of the 28 went on to permanent employment integration in the community and at the end of 2010 6 were still in the program.

There are already 10 community not-for-profit partners in the thrift cooperative program. These agencies cannot afford to operate their own thrift stores so they have their donations brought to the community thrift, their donations are weighed and the donation is documented. At the end of the month, each partner receives a monthly donation report and a check. In 2010, this worked very well and provided these 10 NFP's with a great opportunity to fundraise that they wouldn't have any other way.
