| 28 Part III Line 28 -- Pets for Vets, Inc provides a second chance for shelter pets by rescuing, rehabilitating and pairing them with America's veterans with medical, physical and/or emotional conditions for which a companion animal could be beneficial, all at no cost to the veteran. Ten veterans completed applications, were interviewed and had home visits to ensure pets were permitted and that residences were safe and were pet conducive environments. Trips were made to local shelters to locate the best match for each veteran. The Pets for Vets, Inc. trainer provided board and train services for each rescued pet including basic manners, obedience and possible sensitization to wheelchairs, walkers and/or crutches. The Pets for Vets, Inc. trainer purchased the equipment and supplies that would be needed by the veteran for the first 30 days after receiving his/her Pets for Vets dog. This included a crate, leashes, harness, food, food and water bowls, grooming equipment, treats and chew toys. Veterinarian fees are actual costs to ensure the dogs are healthy and up to date on vaccinations. The executive director maintains contact with the veterans via telephone and email and in person providing ongoing support and training assistance. In addition, the executive director gives presentations to groups, schools and VA hospitals explaining the program and its benefits. The organization's long term goal is to establish chapters in other states in order to provide this service to more veterans. A chapter was established in Washington State the end of December 2010.
