Indonesia - International Channel Foundation - Aceh Sumatra; Grant; Conflict Prevention and Alternative Farming
To see the people of Aceh enjoy an increasing quality of life having been equipped to help both them selves and their neighbors.
Mission is to channel resources to alleviate the suffering of the people of Aceh while empowering local people to achieve sustainable community development. Aceh is the worst affected location in this natural disaster, with massive loss of life and destruction of infrastructure. The people of Aceh have also suffered during armed conflict that has lasted for more than 30 years.
Methodology includes establishing pilot projects of plantation and nurseries for cash crops and animal husbandry which are being used as showroom and training center for agricultural projects in neighboring villages. Serving 450 families(2,000) people.

4b (Code:) (Expenses \$ including grants of \$ **48,000**) (Revenue \$)

Indonesia - Banda Aceh - Community Development; Glenn and Karen Lerich. Providing field coordinators by teaching how to improve water delivery, water health, and hygiene and improving healthcare and health promotion in nearby villages. Supporting short-term humanitarian volunteer teams . Glenn teaches farmers how to use water pumps, service and repair them. Karen is a nurse and provides a health clinic and teaches first aid and water hygiene. Their objective is empower victims of the 2004 tsunami and civil conflicts by helping them improve their standard of living, education and healthcare. Their goals is to encourage persons to be self supp and teach their families and others in the neighborhood, reducing illness.

Indonesia - Aceh Sumatra - Ground Zero - The Source; Facilitates the international community to assist smaller, local NGO's that are working in disaster relief and rehabilitation. The Source brings in international teams and takes them out to various villages to come along local villagers and NGO's to assist their programs. Additionally they help coordination transportation, housing, visa's, finances and target areas of need for the international community to get involved. To get resources to ground zero area quickly.
Providing seed money for framers cooperative and requires accountability.
Includes mobiles clinics, agricultural methods, and small loans. Water sanitation, irrigation, and other rehabilitation.
Vision - To heal, to help, to empower those persons broken by disasters.
