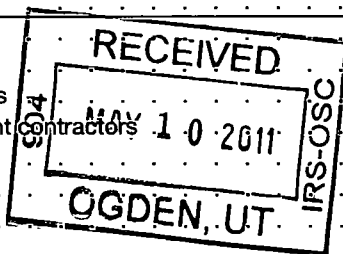



malignancies and other mediastinal diseases, in order to improve the outcomes of people diagnosed with such a condition.

ITMIG has members from North and South America, Europe, Africa, Asia and Australia. It is a multispecialty organization,

involving thoracic surgeons, medical and radiation oncologists, pulmonologists, radiologists, pathologists,

neurologists, and basic science researchers. ITMIG has been recognized by the major bodies governing the organization

of cancer activities: the International Union against Cancer (UICC) and the American Joint Committee on Cancer (AJCC).

ITMIG has undertaken a number of global initiatives.
