DURING THIS TIME THE TEAM WILL (A) DO A COMMUNITY HEALTH SURVEY THAT WILL ALLOW US TO PLAN THE BEST METHODS OF PROVIDING HEALTH CARE SUPPORT (B) PROVIDE TEACHER TRAINING AND (C) HELP PLAN THE CONSTRUCTION OF A NEW SCHOOL BUILDING. THE EXPENSES INCURRED DURING 2010 FOR THIS PROGRAM CONSISTED OF THE COST OF TICKETS AND SCHOOL SUPPLIES FOR TEACHER TRAINING.
