The team is a valuable resource for media educators who wish to grow their skills and develop their students through communication with their peers. Focus will revolve around these following areas:

A. Project based curriculum

B. Assessment

C. Equipment/Software issues and concerns

D. Industry specifications and Certificates

E. Student Leadership and Competition

As part of the Student Competition component, M.E.E.T puts on a yearly film festival with 33 films selected in 11 different categories. These films are selected by a panel of judges who provide written assessments of all films entered to the student filmmaker. The number of films entered each year is approximately 275. Of the 275 films, 33 are selected for the free film festival.
